RESOLUTION 2016-15

The Board of Trustees of Miami Township, Clermont County, Ohio met in regular session at the Miami Township Civic Center on February 16, 2016 with the following members present: Karl Schultz, Ken Tracy and Mary Makley Wolff.

MR. TRACY made a motion to adopt the following Resolution:

RESOLUTION PROVIDING FOR COMPENSATION OF TOWNSHIP EMPLOYEES EFFECTIVE WITH THE FIRST PAY PERIOD OF 2016

WHEREAS, the Board of Trustees is empowered to grant compensation increases to Township employees, and

WHEREAS, various Township employees are eligible for compensation increases effective first pay in January of each year, via employment contract, promotion, annual merit increase, performance incentive or pursuant a collective bargaining agreement, and

WHEREAS, the Board of Trustees has reviewed the proposed compensation increases as presented in the attached schedule.

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Miami Township, Clermont County, Ohio by authority of Chapter 504 of the Ohio Revised Code, as follows:

SECTION 1: That the Board of Trustees approves compensation increases for various Township employees that are eligible for increases the first pay of January of each year, via employment contract, promotion, annual merit increase, performance incentive or pursuant a collective bargaining agreement, according to the attached schedule, and effective first pay in January where applicable.

SECTION 2: That this Board hereby finds and determines that all formal actions relative to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of its Committees, if any, which resulted in formal action, were taken in meetings open to the public, in full compliance with applicable legal requirements, including Section 121.22 of the Ohio Revised Code.


SECTION 3: This Resolution shall take effect at the earliest period allowed by law.

MS. WOLFF seconded the motion to adopt the Resolution. On the roll call being called the vote resulted as follows:


